Giving **Changes** Everything.

Type	When	Purpose
Gift of Residual Interest	<b>Today:</b> Gift in Lifetime (Inter vivos)	<ul style="list-style-type: none"> <li>Donor gives property now (e.g., home, land) but keeps use of it for life.</li> <li>Charity receives it upon the donor's passing.</li> </ul>
Charitable Remainder Trust (CRT)	<b>Today:</b> Gift in Lifetime (Inter vivos)	<ul style="list-style-type: none"> <li>Donor receives income for life or term.</li> <li>Remainder passes to charity.</li> <li>Receipt for the present value of remainder may be allowed.</li> </ul>
Alter Ego or Joint Partner/ Spousal Trust	<b>Future:</b> Estate Planning (Age 65+)	<ul style="list-style-type: none"> <li>Donor retains income and control while alive.</li> <li>Tax deferral: No capital gains tax when assets transfer to the spousal trust upon the first spouse's passing.</li> <li>Avoids probate.</li> <li>Charity can be a remainder beneficiary, with tax receipt for the estate.</li> </ul>
Testamentary Trust	<b>Future:</b> Estate (via Will)	<ul style="list-style-type: none"> <li>Created through a Will.</li> <li>Assets distributed after death, including charitable gifts.</li> </ul>
